Medicaid

- CLPPP will work to have one or two Medicaid Health Plans (MHPs) representatives on a future call to talk about how local health departments (LHDs) and MHPs can better coordinate care
- Care Coordination Agreement (CCA) has not been finalized. The latest is that the health director's suggested forming a workgroup with MDHHS Medicaid and LHDs to develop a mutual understanding around all the projects/programs that require a CCA. This is under consideration at Medicaid. MDHHS CLPPP will keep the LHDs updated about the progress of this.
